Please read and acknowledge the following with your signature:

1. I hereby agree, as consideration for the granting of this permit, that the following terms and conditions govern my use of the permit, my presence on LRBOI Tribal lands, and my use of Tribal resources and services.
2. I agree to obey all Tribal, Federal, and State laws and regulations.
3. I consent to the jurisdiction of the Little River Band of Ottawa Indians Tribal Court as the forum for the resolution of any criminal or civil disputes that arise from my use of this permit to enter onto Tribal lands.
4. I understand that the permission for me to enter onto Tribal lands and to utilize the Natural Resources is a conditioned on my good conduct in observance of Tribal, Federal, and State laws and regulations, and that violation of such laws and regulations may make me a trespasser and may subject me to arrest by Little River Band of Ottawa Tribal Enforcement Officer, Tribal and Federal court action, expulsion from Tribal lands, and

seizure of property as security for payment of potential financial obligations to the Tribe.

5. **I understand that willfully using Tribal resources of services contrary to the terms of Tribal Laws or Regulations constitutes theft of Tribal assets and is a violation of Tribal and Federal law.**
6. **I understand that all harvest on Little River of Ottawa Indians lands shall be reported to the Little River Band of Ottawa Indians Natural Resource Department.**
7. **I understand that, when harvesting of Natural Resources within the Little River Band of Ottawa Indians lands, I am required by Tribal law to have a State of Michigan license or permit, as required by the State, or if I am a member of a tribe that has entered into a reciprocal agreement with the Little River Band of Ottawa Indians, a permit from my tribe authorizing me to participate in such harvesting activities.**
8. **By my signature, I release the Little River Band of Ottawa Indians from any claim for injury or damage resulting from my activities within the Little River Band of Ottawa Indians lands.**
9. **I understand that I am to carry a Trespass Permit with me at all times when entering within the Little River Band of Ottawa Indians lands and also while in the possession of any legally taken resource from the Little River Band of Ottawa Indians lands as document for all off reservation transport.**
10. **The sponsor for the non-tribal member is required to co-sign this permit.**
11. **A person that has a felony conviction will follow Tribal, State, and Federal laws.**
12. **This permit will only be valid for the year that it was issued in.**
