### Resolution # 09-0121-26

*Approving addendum #1 to R Clark and Associates Contract and authorizing the Ogema to sign the Addendum with R Clark and Associates for Indian Reservation Roads Inventory updates*

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land; to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, The LRBOI Planning Department is charged with managing the Tribe's Indian Reservation Roads Program which includes roads inventory updates; and

WHEREAS, the Tribal Ogema has negotiated a contractual agreement with R Clark and Associates for the creation of the LRBOI Indian Reservation Roads Inventory Updates; and

WHEREAS, the Tribal Council agrees to authorize the Ogema to sign said contract with R Clark and Associates; and

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the Ogema to sign the Addendum #1 to the contractual agreements with R. Clark and Associates
