### Resolution # 09-1014-299

#### *Authorize Revenue Sharing Account at National City for Little River Casino Resort*

- WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council has the power under Article IV, Section 7 (f) to create subordinate organizations and to delegate to such organizations the power to manage the enterprises of the Tribe; and
- WHEREAS, the Tribal Council established the Board of Directors Act of 2005 Ordinance #05-800-03; and
- WHEREAS, under Article V, 5.01 b of this ordinance that the Board of Directors shall be responsible “to account for and transfer, or to direct the accounting and transfer of, all revenues generated by the Little River Casino Resort, excluding authorized operating funds, on at least a 48 hour basis *to an account or accounts authorized and established by the Tribal Council by law or resolution (sic)...*”; and


NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby ratifies the deposit account/loan/lease resolution establishing an account (number 700569353) named Little River Casino Resort – Revenue Sharing Account.


