Resolution No. #00-0311-_22

Authorizing the Tribal Ogema, or in his absence, the Tribal Council Speaker to Execute Documents Necessary to Complete the Acquisition of the Rental Housing Units

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribal Council and Tribal membership has determined that restoration of the Tribe's historic reservation land base and other lands within the Tribe's historic territory is a critical priority;

WHEREAS, the Congress of the United States has recognized the Tribe's historic claim to Reservation lands in Manistee and Mason Counties in Michigan, as well as the Tribe's traditional ties to other Counties in Michigan; and

WHEREAS, the Tribal Council has adopted a Reservation Restoration Plan to guide land acquisition efforts by the Tribe and the Secretary of the Interior; and

WHEREAS, the Tribe's Reservation Restoration Plan establishes as a priority, the acquisition of lands for community development purposes, including housing development; and

WHEREAS, the Tribe's Housing Commission has, pursuant to the terms of a certain purchase agreements contracted the purchase four rental properties, which properties are described as follows:

The City of Manistee, Lot Seventeen (17), Block two (2), amended Plat of Engelmann's Addition to the City of Manistee, According to the Plat Thereof As Recorded in Liber 2-A of Plats, Page 19, also known as 194 Quincy Street;

The West Half of Lot Six (6), Block Fourteen (14) of the Freeland Addition to the City of Manistee, According to the Plat Thereof as Recorded in Liber 2-A of Plats, Page 9, also known as 230 Ninth Street;

City of Manistee, Lot One (1), Block Eight (8), Except the North 78 Feet of the West 7 Feet Thereof, Ramsdell and Benedict's North Addition to the City of Manistee, According to the Plat Thereof as Recorded in Liber 2-A of Plats, Page 5, also known as 148 Ford Street; and

The West Half of Lot Seven (7), Block Twenty-two (22), the Freeland Addition to the City of Manistee to the City of Manistee, According to the Plat Thereof as Recorded in Liber 2-A of Plats, Page 9, also known as 909 Davis Street; and

WHEREAS, the Tribal Council has, pursuant to Resolution No. #00-0124-03 and Resolution No. #-00-0124-04, approved the Operating Budget for Fiscal Year 2000 and an Appropriation of Funds for First Quarter Requirements for the Tribal Government, which included an appropriation of funds for the acquisition of rental units; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(c) of the Constitution, has the power to acquire lands which are deemed beneficial to the Tribe; and

WHEREAS, pursuant to Article IV, Section 5 (a)(4) and Article V, Section 5(a)(3) and (8) of the Tribal Constitution, the Tribal Ogema, or in his/her absence, the Council Speaker is authorized to represent the Tribe in its relations with other organizations and manage the economic affairs/enterprises of the Tribe, in a manner consistent with the Tribal Constitution and resolutions of the Tribal Council.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the Tribal Ogema, or in his absence, the Tribal Council Speaker, Joan Spalding, to execute any documents necessary to complete the purchase of the rental properties described above at a date and time mutually agreeable to the Tribe and sellers.

IT IS FURTHER RESOLVED THAT the Tribal Council directs the Tribal Attorney to approve all documents prior to the closing and to represent the Tribe at Closing.
