Approving Budget Modification in the Amount of \$10,000.00 to Appropriate General Revenue Funds for Membership Dues in the National Indian Gaming Association

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power the provide for the general welfare of the Tribe and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, 7(i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the Gaming Commission has recommended that the Tribe become an active member in the National Indian Gaming Association; and

WHEREAS, the National Indian Gaming Association (NIGA) is a voluntary association of member Tribes an Associate members representing federally recognized Tribal governments, gaming Tribes, Bands and businesses engaged in gaming enterprises in Indian Country; and

WHEREAS, the primary purposes of NIGA are to promote, protect and preserve the general welfare and interests of gaming Tribes through the development of sound policies and practices with respect to the conduct of gaming in Indian Country, to assist in the dissemination of information to the Indian gaming community, the federal government and the general public on issues related to

Indian gaming, to preserve and protect the integrity of gaming in Indian County, and to maintain, protect and advocate Indian Tribal sovereignty; and

WHEREAS, the appropriation of funds from the General Revenue Fund account will require a modification of the Operating Budget for Fiscal Year 2000, which was approved on January 24, 2000; and

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification of to the Operating Budget for the Tribal Government for Fiscal Year 2000 to include an additional appropriation of \$10,000.00 from the General Revenue Fund for payment of dues for NIGA membership.

IT IS FURTHER RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby appoints Robert Guenthardt, Ogema **Alter** as the Tribe's representative to NIGA, with Joan Spalding, Council Speaker and Janine Szpliet, Councilor as alternates.

IT IS FURTHER RESOLVED THAT the appointments for the above individuals will remain in effect for balance of calendar year 2000 or until replaced by the Council.
