Approving Budget Modification to the Fiscal Year 2000
Operating Budget for the Tribal Government Operations to
Reflect the Transfer of Funds from the Community & Economic
Development Department (Prog. #368) to Establish a New
Program (Professional Development & Training) within
the Internal Service Fund

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power the provide for the general welfare of the Tribe and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, 7(i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the Tribal Council has previously approved the operating budget for the Community & Economic Development Department, as a program within the Tribal Government's Operating Budget, which budget is funded with a combination of General Funds and Special Revenue Funds; and

WHEREAS, the Tribal Ogema, has developed a proposal for the establishment of a Professional Development and Training Department, which was not specifically contemplated in the Fiscal Year 2000 Operating Budget, as enacted; and

WHEREAS, the Tribe's Controller has recommended funding the Professional Development and Training program by transferring a total of \$77,444.00 in Special Revenue Funds from Program #368 to the Internal Service Fund, in accordance with the line item transfers described on the budget proposal attached hereto; and

WHEREAS, the transfer of the funds from Program #368 to the Internal Service Fund to establish a Professional Development and Training program will require a modification of the Operating Budget for Tribal Government Operations for Fiscal Year 2000, which was approved on January 24, 2000.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification of to the Operating Budgets for the Tribal Government and Little River Casino Resort for Fiscal Year 2000 to transfer \$77,444.00 in Special Revenue Funds from Program #368 to the Internal Service Fund for the establishment of a new program for Professional Development and Training, which will be assigned a new Program Number for financial reporting.

Primary Goal

Provide technical assistance in the use of Microsoft® Office products and further the proficiency in the use of such products to all Little River Band of Ottawa Indians members. Develop a training center to meet the academic and vocational needs for of Little River Band members.
