Approving Budget Modification to the Fiscal Year 2000 Operating Budget for the Tribal Government and Appropriating Up to \$1,300,000.00 of General Revenue Funds to Complete the Purchase of the "Pere Marquette River" Property

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribal Council and Tribal membership have determined that restoration of the Tribe's historic reservation land base and other lands within the Tribe's historic territory is a critical priority;

WHEREAS, the Tribe's Reservation Restoration Plan has identified acquisition of lands within the Mason County Reservation as a priority; and

WHEREAS, the Tribe has identified the "Pere Marquette River" property in Custer Township as parcel of land which includes lands that have great historical and cultural significance to the Tribe, and which would be suitable for multiple uses in the development of Tribal programs; and

WHEREAS, the Tribal Council believes that the "Pere Marquette River" property affords the Tribe with a unique opportunity to acquire lands within its historic Reservation that will meet the long term needs of the Tribe and allow the Tribe to reclaim historically significant lands to Tribal ownership; and

WHEREAS, the Tribes has previously authorized execution of an Agency Agreement with Wilcox Realty Associates (hereafter "Wilcox") of St. Clair Shores, Michigan, so that Wilcox could enter into a purchase agreement for the "Pere Marquette River" property, which keeping the Tribe's interest in this property confidential; and

WHEREAS, under the terms of such Agency Agreement, Wilcox negotiated a Purchase Agreement to acquire the "Pere Marquette River" for \$1,300,000.00; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council, pursuant to Article IV, 7(i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the appropriation of up to \$1,300,000.00 from the General Revenue Fund account to cover the costs of completing the acquisition of this property will require a modification of the Operating Budget for Fiscal Year 2000, which was approved on January 24, 2000.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification of the the Operating Budget for the Tribal Government for Fiscal Year 2000 to include an appropriation of up to \$1,300,000.00 from the General Revenue Fund to be used to cover the costs associated with completing the purchase of the "Pere Marquette River" property.
