Resolution No. #00-1023-02

Approving Supplemental Appropriation from the General Fund in the amount of \$30,000.00 to Supplement the Rental Assistance Program Administered by the Housing Commission (Program #378)

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power the provide for the general welfare of the Tribe and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, 7(i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the Housing Commission has administered a Rental Assistance Program to provide qualified, low-income Tribal families with rental assistance;

WHEREAS, the level of need for this service has far exceeded the \$15,000.00 included in the Fiscal Year 2000 Operating Budget for the Tribal Government; and

WHEREAS, the continuation of these critical services to Tribal members requires a supplemental appropriation in the amount of \$30,000.00 in order to meet the needs of Tribal member families through the end of Fiscal Year 2000; and

WHEREAS, the appropriation of funds from the General Revenue Fund account will require a modification of the Operating Budget for Fiscal Year 2000, which was approved on January 24, 2000.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification of the Operating Budget for the Tribal Government for Fiscal Year 2000 to include a supplemental appropriation of \$30,000.00 from the General Revenue Fund to be allocated to the Special Revenue Fund - Program #378 (Rental Assistance).
