Resolution No. # 00-1128-07 Approving Proposal for USDA Financing Programs for Community and Economic Development Available in Michigan

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council, pursuant to Article IV, 7 of the Constitution has the power to enact ordinances and resolutions to promote the general welfare of the Tribe and its members; and
- WHEREAS, the Tribe has developed a proposal for a Community Facility Program which is currently in Phase I, and
- WHEREAS, the purpose of this program is to develop governmental administrative office space which will assist in moving governmental program access into the areas of need, and
- WHEREAS, the Little River Band has determined that providing housing and public safety is an immediate need and concern for the members of the Tribe, and
- WHEREAS, the proposed Community Facility will bring public safety offices and housing program offices into the housing development sites for ease of access and on-site management of the housing program units, and
- WHEREAS, this proposed integration of administrative offices will bring the program and constituents into a close working relationship to better identify, define and provide services, and
- WHEREAS, the Community Facilities Program Phase I loan will be utilized to build a facility, provide for the purchase of equipment and operating costs of the facility, and
- WHEREAS, the Little River Band is submitting this request for a loan of \$750,000 which is up to 100% of the market value of the facility to provide for essential community facilities for the rural community needs,

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approve the loan request for Community Facility Program - Phase I in the amount of \$750,000, and

NOW THEREFORE BE IT RESOLVED, that the Tribal Council does hereby authorize the Tribal Ogema, or in his absence the Tribal Speaker, to complete the application for submission and to direct that the Tribal Ogema bring back the necessary documents for approval and authorization to the Tribal Council upon approval of the application.

IT IS FURTHER RESOLVED THAT the Tribal Council hereby approves the development of the appropriate budget allocations for Fiscal Year 2001.
