Establishing the Schedule of Regular Meetings for the Tribal Council for Calendar Year 2001

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 6(a) of the Constitution is required to meet in regular session at least once every month at a time and place to be set by the Tribal Council; and
- WHEREAS, the Constitution provides that the "schedule of meetings for regular sessions of the Tribal Council for [each succeeding] calendar year shall be set by resolution of the Tribal Council at the last regular session of each calendar year" and that such schedule "shall be published and made available to the General Membership;" and
- WHEREAS, the Tribal Council met to discuss and agreed upon a schedule for regular sessions of the Tribal Council for calendar year 2001; and
- WHEREAS, the Tribal Council desires to have the greatest input from the General Membership in all considerations of government action such that meetings should be regularly scheduled that allow for comment and discussion with the General Membership; and
- WHEREAS, in accordance with Article IV, section 6(e) of the Constitution, the Tribal Council does hereby set the third Saturday of every month, from 10:00 a.m. to 4:00 p.m. as a regular meeting of the Tribal Council specifically identified to present information from the Tribal Council, to receive comments, and to hold discussions with the General Membership on legislation and other activities of the Tribal Council during the previous month or as part of the upcoming month, including receiving departmental reports and minutes of entities of the Tribe; and
- WHEREAS, it has been determined by the Tribal Council that the General Membership benefits from a Tribal Council which meets on a regular weekly basis and that regular meeting shall include an Agenda Review meeting held Tuesday's from 10:00 a.m. to 12:00 p.m. to go over and present items for the weekly agenda, and that Wednesdays from 1:00 p.m. until

concluded shall be the regular weekly agenda, excluding July 4th and October 31st; and

WHEREAS, as part of this weekly schedule, the Tribal Council shall set Friday, at close of business, of the week prior to be the deadline for receiving items on the regular meeting agenda; and

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby set the schedule of regular meetings of the Tribal Council for the Calendar Year 2001 to be every Wednesday, at 1:00 p.m., and the third Saturday of each month from 10:00 a.m. to 4:00 p.m.; and

IT IS FURTHER RESOLVED THAT the Tribal Council hereby sets the location of those regular meetings as the Little River Community Center until such time as another permanent meeting location can be established.

CERTIFICATE OF ADOPTION
