Resolution No. #01-0117-________

Authorizing the Tribal Ogema, or in his absence, the Tribal Council Speaker to Execute a Construction Agreement with Domres Construction for a water tap installation to the Downtown Office Building of the Little River Band of Ottawa Indians (formerly the National City Bank Building)

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribal Administration has a critical need for additional office space to accommodate the development of Tribal programs anticipated in the coming months; and

WHEREAS, the Tribal Administration has developed a budget for the estimated costs associated with renovating the Downtown Office building to accommodate the Tribal government's need for office space; and

WHEREAS, the Tribe requires retention of a firm with sufficient technical expertise to install a water tap for the Downtown Office building; and

WHEREAS, Domres Construction has submitted a proposal for the water tap installation to the Downtown Office building; and

WHEREAS, under the terms of that proposal, Domres Construction will, in consultation with the Tribal Administration, prepare a scope of work and construction documents for the water tap installation to the Downtown Office building; and

WHEREAS, representatives of Domres Construction have presented a proposal to complete the water tap installation to the Downtown Office building at a cost not to exceed \$_____, and

WHEREAS, the Tribe adopted a Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
