APPROVING STATEMENT OF FEES AND EXPENSES FROM PENINSULA LEGAL SERVICES FOR SERVICES TO THE ELECTION BOARD DURING THE MONTHS OF JUNE through DECEMBER 2000

WHEREAS, the Tribal Council of the Little River Band of Ottawa Indians is the governing body of the Tribe, pursuant to the Tribe's Constitution; and

WHEREAS, the Tribal Council, did approve a Special Counsel Contract with Peninsula Legal Services, P.C., for a period commencing October 14, 1999, which contract has been amended by the Tribal Council, pursuant to Article IV of the Band's Constitution; and

WHEREAS, the Tribal Council has reviewed the statement of legal services performed and expenses incurred by Peninsula Legal Services on behalf of the Election Board during the months of June, July, August, September, October, November and December 2000; and

WHEREAS, circumstances arose which substantially increased the number of hours required in order for Peninsula Legal Services to complete the scope of work contemplated in the Contract, as amended; and

WHEREAS, the amounts charged by Peninsula Legal Services for legal services during the Contract Year commencing October 14, 1999 and running through October 13, 2000, was \$177,483.25; and

WHEREAS the Tribal Election Board has certified that the legal services provided by Peninsula Legal Services were necessary, that statement of fees and expenses for such services is correct and recommends payment of the amounts charged; and

WHEREAS, the Tribal Election Board recognizes that the amounts charged for legal services between October 14, 1999 and October 13, 2000, exceed the

RESOLUTION NO. #01-0124- Page 2 of 3 contract ceiling for fees by \$51,837.25 and that authorization of payment will require a supplemental appropriation of funds; and

NOW THEREFORE IT IS RESOLVED THAT, subject to approval of an appropriation of funds for this purpose, the Tribal Council of the Little River Band of Ottawa Indians hereby approves for payment the following amounts for the months of June, July, August, September, October, November and December 2000:
