WHEREAS, the Tribal Council of the Little River Band of Ottawa Indians is the governing body of the Tribe, pursuant to the Tribe's Constitution; and

WHEREAS, the Tribal Council, did approve a Consulting Contract with James M. McClurken & Associates, for a period commencing May 1, 2000; and

WHEREAS, the Tribal Attorney has reviewed the statement of legal services performed and expenses incurred by McClurken & Associates during the months of December 2000 and January 2001 and has recommended payment of such fees and expenses; and

WHEREAS the Tribal Attorney has represented that the amounts billed for fees and expenses are reasonable, that amounts billed are within the amount allowed under the Contract, and that funds are available to pay such charges.
