Resolution No. #01-0303-01

Approving Capital Budget for Little River Casino Resort Expansion

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereafter "Little River Act"); and
- WHEREAS, the Tribe adopted a Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe is entitled to the protections and benefits accorded federallyrecognized Indian tribes under federal law, including those under the Indian Gaming Regulatory Act of 1988 (25 U.S.C. §2701 et seq.)(hereinafter "IGRA"), which permits Indian tribes to operate Class II and III gaming activities on lands held in trust for the Tribe; and
- WHEREAS, the Tribe has determined that the development of the permanent casino/resort facilities is in the best, long-term interests of the Tribe and its members; and
- WHEREAS, casino/resort facilities will include: expanded casino floor, "back of the house", offices, restaurants, hotel, RV Park and related infrastructure improvements; and
- WHEREAS, the Tribal Ogema, in consultation with the Tribe's Controller, Project Accountant, and the Chief Financial Officer for Little River Casino Resort, has prepared a capital budget proposal for all costs associated with the proposed Little River Casino Resort (the "Resort") Expansion, including the costs associated with development and construction of the community water and wastewater treatment facilities serving the Resort; and
- WHEREAS, the Tribal Council, pursuant to Article IV, 7(i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

- WHEREAS, the Tribal Council, pursuant to Resolution No. #00-1111-06, appropriated \$8 Million Dollars in General Funds to be used in connection with development activities required to complete the proposed expansion of the Casino Resort facilities (the "Project"); and
- WHEREAS, the terms of Resolution No. #00-1111-06, require any allocation or use of funds under that appropriation to be approved by Resolution of the Tribal Council until such time as Capital Budget is approved for the Project.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby adopts the Capital Project Budget for the Casino Resort Permanent Facility project, dated February 20, 2001, as identified in Attachment I to this resolution; and

IT IS FURTHER RESOLVED THAT the Tribal Council hereby authorizes the Construction Management Team (CMT) to expend budgeted funds for Project Hard Costs, Water/Sewer Project Costs and Pre-Development Costs as approved in the Capital Project Budget and in accordance with the procedures, authority and limitations prescribed in Resolution No. #01-0110-03, as amended, and in accordance with any accounting procedures which may be now or hereinafter set forth; and

IT IS FURTHER RESOLVED THAT the limitations on spending authority imposed by Resolution No. #00-1111-06 is hereby repealed.

IT IS FINALLY RESOLVED THAT the Tribal Council finds that the Capital Project Budget Narrative contains proprietary information and that the Budget document for the Casino Resort Permanent Facility project shall be a confidential, non-public document which may not be released or viewed without approval of the Tribal Council, and that the Tribal Ogema is requested to create a Capital Project Budget Narrative-Public version for viewing by the Tribal membership or other approved persons.
