**Authorizing Use of the Tribal Seal in Connection with Little River Band of Ottawa  
Indians Annual Pow-Wow's**

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. § 1003k et seq.)(Hereinafter "Little River Act"); and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe has enacted a Tribal Seal Ordinance, Ordinance No. 96-100-01, as amended, which adopts a Seal for the Tribal Government and which regulates and restricts the use or facsimiles, reproductions or impressions of the Tribal Seal; and

WHEREAS, Section 4.03 of the Tribal Seal Ordinance prescribes limitations on the commercial use of the Tribal Seal or like reproductions in connection with official functions of the Tribe; and

WHEREAS, the Pow-Wow team of the Cultural Preservation Committee has requested authorization to use the Tribal Seal on T-shirts to be sold at and in support of the Tribal Pow-Wow's; and

WHEREAS, Section 4.03 of the Tribal Seal Ordinance requires that commercial use of the Tribal Seal, with or without the wording associated with Seal, be authorized by the Tribal Council.

NOW THEREFOR IT BE RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the Pow-Wow team of the Cultural Preservation Committee to use the Tribal Seal, without the wording associated with the Seal, on T-shirts for sale in connection with Tribal Pow-Wows, subject to the following conditions:

- (a) The Pow-Wow Team shall account for the specific number of shirts acquired for sale in connection with Pow-Wows; and






- (b) The vendor selected to produce the T-shirts shall obtain a permit to do business with the Tribe from the Tribal Ogema, which permit authorizes the purchase of T-shirts from that vendor and which informs such vendor of the restrictions on commercial use of the Tribal Seal; and
- (c) The Pow-Wow team shall account for all expenses and income associated with the purchase and sale of shirts bearing the Tribal Seal and all profits from the sale of items shall be turned over to the Cultural Preservation Committee.

**CERTIFICATE OF ADOPTION**
