

Resolution No. # 01-0321-12 Delegating to the Construction Management Team Responsibilities Regarding Contracting for the Furniture, Fixtures & Equipment Expenditures

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k <u>et</u> <u>seq</u>.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Constitution delegates to, and authorizes the Tribal Council to, "...authorize and ratify agreements and contacts negotiated by the Tribal Ogema on behalf of the Little River Band with federal, state, and local governments and other Indian tribes or their departments or political subdivisions, or with private persons on all matters within the authority of the Tribal Council[,]" Article IV, Section 7(b); and
- WHEREAS, the Tribe has determined that a Construction Management Team is necessary to manage the Furniture, Fixtures and Equipment Budget (*FF&E Budget*) to allow for the Little River Casino Resort Expansion Project (*Expansion Project*) to be completed in a timely and financially responsible manner; and
- WHEREAS, the Tribal Council desires to set forth processes by which the Construction Management Team may identify and develop contracts for the expansion project; and
- WHEREAS, the Tribal Council desires to delegate certain limited legislative authority under Article IV, Section 7(b) of the Constitution to the Construction Management Team to ratify contracts which are created under the processes set forth in this resolution, by which the expansion project may continue to move forward in a reasonable and organized manner; and
- WHEREAS, the expansion project currently has an approved budget which identifies the estimated cost for the individual parts/activities of the FF&E portion of the expansion project, through Tribal Council Resolution # 01-0303-01;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby delegates to the Construction Management Team (CMT) the responsibility of managing the FFE Budget of the expansion project; and

IT IS FINALLY RESOLVED THAT the Tribal Council hereby delegates the following duties, responsibilities and authorities to the CMT:

Serving Kent, Lake, Manistee, Mason, Muskegon, Newaygo, Oceana, Ottawa and Wexford Counties A. Request for Bids. The CMT shall approve the form of all Request for Bids or Request for Proposals (RFP) to be sent to proposed vendors for the FFE portion of the expansion

B. Approval of Vendors. The CMT shall receive the responses to RFP's and make a final selection of the vendor who will be awarded the bid.

C. Contracting and Review. The CMT shall, in conjunction with the Tribe's Legal Department, negotiate and approve contracts for the winning bidders of RFP's.

D. Entering into Contracts. The CMT shall be delegated authority to enter into contracts directly related to the FFE portion of the expansion project where such contracts are under within the approved budget and where such contracts do not contain a waiver of sovereign immunity of the Tribe. The CMT shall maintain originals of all contracts, and submit copies of all contracts to the Tribal Council, with summaries of the contracting process, for information only purposes. Provided that, all other contracts shall be forwarded for approval by the Tribal Council. Provided further, that all contracts shall be signed by the Tribal Ogema, or in his/her absence, the Tribal Council Speaker.
