RESOLUTION NO. 01-04-04-01

RURAL HOUSING ECONOMIC DEVELOPMENT GRANT APPLICATION

WHEREAS, The Little River Band of Ottawa Indians has a long and proud history as a Nation which pre-dates the establishment of the government of the United States of America, and

WHEREAS, The Little River Band of Ottawa Indians was a signatory of the Treaty of Washington of March 28, 1836 and the Treaty of Detroit of July 31, 1855 with the United States of America, and

WHEREAS, The Little River Band of Ottawa Indians status as a federally-recognized Tribe was reaffirmed and restored by the United States Congress in Public Law 103-324, and

WHEREAS, The Little River Band is committed to provide safe, sanitary water to the homes connected to the community water system and a sanitary method of liquid waste disposal, and

WHEREAS, The Little River Band of Ottawa Indians has a need for housing for our membership and that housing will need water and sanitary sewer facilities to support that housing , and

WHEREAS, The Little River Band of Ottawa Indians has determined a specific need for a water tower to be located where it may serve our housing development, and

WHEREAS, The Little River Band of Ottawa Indians is working closely with the Indian Health Services in determining the best water tower to serve our housing development, and

WHEREAS, The Little River Band of Ottawa Indians has found that the Department of Housing and Urban Development has funding available for grants that would provide funds to build a water tower, and

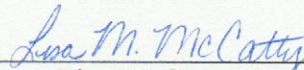
WHEREAS, The Little River Band of Ottawa Indians Tribal Council wish to seek grant funding from the Department of Housing and Urban Development to provide a water tower for our housing complex

NOW THEREFORE BE IT RESOLVED THAT the Little River Band of Ottawa Indians by this resolution wishes to apply for a grant from the Department of Housing and Urban Development in the amount of \$400,000 to assist the Little River Band in establishing a community water system.

BE IT FURTHER RESOLVED THAT the Little River Band of Ottawa Indians Tribal Council commits to providing the balance of \$100,000 for purchase of the Water Tank for the community water system.

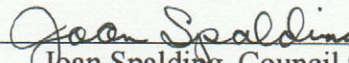
CERTIFICATION OF ADOPTION
