Approving a Budget Modification to the Operating Budget for the Tribal Government for Fiscal Year 2001 to Include an Appropriation of \$13,606.00 from the General Fund for Completion of Site Improvements to the Tribe's Pow Wow Grounds

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power the provide for the general welfare of the Tribe and its members; and
- WHEREAS, the Tribal Council, pursuant to Article IV, 7(i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and
- WHEREAS, the Tribal Ogema and the Tribe's Cultural Preservation Committee have recommended completion of improvements to the Tribe's Pow Wow grounds; and
- WHEREAS, Cultural Preservation Committee members have solicited proposals from a number of companies to level, spread top soil and hydroseed approximately 1 acre at the Tribe's Pow Wow grounds; and
- WHEREAS, the contractor recommended by the Tribal Ogema and Cultural Preservation Committee has agreed to complete the work required for the sum of \$13,606.00; and

WHEREAS, the appropriation of funds from the General Fund account will require a modification of the Operating Budget for Fiscal Year 2001, which was approved on December 20, 2000; and

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification of to the Operating Budget for the Tribal Government for Fiscal Year 2001 to include an additional appropriation of \$13,606.00 from the General Fund Account for payment of fees associated completion of the improvements to the Tribe's Pow Wow grounds.
