Resolution No. #01-0418-05

Authorizing the Tribal Ogema, or in the absence of, the Tribal Council Speaker to Execute a Contract with Seng Crane & Excavating, Inc., to Site Work and Hydroseeding of Pow Wow Grounds

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, pursuant to Article IV, Section 5 (a)(4) and Article V, Section 5(a)(3) and (8) of the Tribal Constitution, the Tribal Ogema, or in the absence of the Tribal Council Speaker, is authorized to represent the Tribe in its relations with other organizations and manage the economic affairs/enterprises of the Tribe, in a manner consistent with the Tribal Constitution and resolutions of the Tribal Council; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (b) of the Constitution, has the power to authorize and ratify agreements and contracts negotiated by the Tribal Ogema; and
- WHEREAS, the Cultural Preservation Committee has solicited bid proposals from several consulting firms to complete site leveling and hydroseeding of the Tribe's Pow Wow grounds; and
- WHEREAS, the Cultural Preservation Committee and Tribal Ogema are recommending acceptance of the proposal submitted by Seng Crane & Excavating, Inc., based upon price and ability to complete the work in accordance with specifications prescribed by the Cultural Preservation Committee; and

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the Tribal Ogema, or in the absence of, the Tribal Council Speaker, to execute a proposal and professional services agreement with Seng Crane & Excavating, Inc., to complete the site leveling, site preparation and hydroseeding of the Tribal Pow Wow grounds as described in the attached proposal.
