Amendment/Designation of Authorized Check Signers on Certain Tribal Accounts

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. '1300k et seq.)(hereinafter "Little River Act"); and

- WHEREAS, the Tribe has established a number of general and specialBpurpose checking accounts with Huntington National Banks; and
- WHEREAS, the Tribal Council has, by Resolution, designated the authorized check signers for such general and special-purpose checking accounts; and
- WHEREAS, changes on the Tribal Council following Tribal Elections make it necessary and prudent to amend and re-designate the persons authorized to sign checks from certain accounts.
