Authorizing Transfer of Certain Tribal Accounts to National City Bank and Affirming Designation of Check Signers for such Accounts

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribal Council has, pursuant to Resolution, established a number of general and special-purpose checking accounts with Huntington National Banks; and
- WHEREAS, the Tribal Council has, by Resolution, designated the authorized check signers for such general and special-purpose checking accounts; and
- WHEREAS, the Tribal Ogema and Chief Financial Officer have recommended transferring a number Tribal accounts from Huntington National Banks to National City Bank of Michigan/Illinois in order to economize certain financial management functions; and
- WHEREAS, the Tribal Council supports the recommendation of the Chief Financial Officer and wishes to authorize transfer of the accounts identified.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the Tribe's Chief Financial Officer to transfer the following accounts from Huntington National Banks to National City Bank of Michigan/Illinois:
