Acceptance of Indian Community Development Block Grant (ICDBG) Program funds from HUD to provide for the construction of the Wastewater Treatment Facility and Approving a modification to the Operating Budget for Fiscal Year 2001 in the amount of \$500,000

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and
- WHEREAS, the acceptance of grant funds from the U.S. Department of Housing and Urban Development (HUD) will require a modification of the Operating Budget for Fiscal Year 2001, which was approved on December 20, 2000.
- NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for Fiscal Year 2001 to include grant funds in the amount of \$500,000 from HUD to provide for the construction of the Wastewater Treatment Facility.
- IT IS FINALLY RESOLVED THAT the Tribal Council authorizes the Tribal Ogema, or in his absence, the Tribal Council Speaker to execute any documents necessary to officially accept grants funds from the U.S. Department of Housing and Urban Development for the construction of the Wastewater Treatment Facility.
