Resolution No. #01-1017-0

Approving Supplemental Appropriation from the General Fund in the amount of \$30,000.00 to Fund the Higher Education Computer Grant Program in the Education Department (Program #1002-1015)

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power the provide for the general welfare of the Tribe and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, 7(i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the Tribe's Education Department is in need for additional funding for the Higher Education Computer Grant program to provide qualified Tribal members enrolled in institutions of higher learning with a laptop computer;

WHEREAS, the Education Department requires a supplemental appropriation in the amount of \$30,000.00 in order to fund that program for qualified Tribal member students who are enrolled in the Fall 2001-2002 academic year, which begins in September 2001; and

WHEREAS, the appropriation of funds from the General Revenue Fund account will require a modification of the Operating Budget for Fiscal Year 2001;
