Ratifying the Tribal Ogema's Execution of a Consulting Agreement with Darren Mitchell to Assist with Training and Implementation of Tribally-licensed Commercial Trap Net Fishing Operations

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and

- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, pursuant to Article IV, Section 5 (a)(4) and Article V, Section 5(a)(3) and (8) of the Tribal Constitution, the Tribal Ogema, or in the absence of, the Tribal Council Speaker, is authorized to represent the Tribe and manage the economic affairs/enterprises of the Tribe, in a manner consistent with the Tribal Constitution and resolutions of the Tribal Council; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (b) of the Constitution, has the power to authorize and ratify agreements and contracts negotiated by the Tribal Ogema; and
- WHEREAS, the terms of the Consent Decree entered in <u>United States</u> v <u>Michigan</u> are intended to facilitate the Tribe's to use settlement funds to assist Tribal members enter the commercial fishery in waters near the Tribe's Reservation; and
- WHEREAS, the Tribal Council, pursuant to Resolution No. #01-0926-___, did approve the appropriation of funds to be used to purchase equipment to be leased to Tribal member fishers and to cover fees of consultants retained to train Tribal members in the operation of trap net fishing operations; and

WHEREAS, in furtherance of those budgeted purposes, the Tribal Ogema has negotiated a Consultant Agreement with Darren Mitchell to provide consulting services to the Tribe and Tribal members licensed to engage in commercial fishing operations, which Agreement has been presented for ratification.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby ratifies the Consulting Agreement with Darren Mitchell, which has been executed by the Tribal Ogema on behalf of the Tribe.
