Resolution No. #01-1024-0

Approving Supplemental Appropriation for Cultural Preservation Program for FY2001 in the amount of \$14,705 from General Fund

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and
- WHEREAS, the Cultural Preservation Program requires a supplemental appropriation in the amount of \$14,705 for costs associated with improvements to the Pow Wow Grounds; and
- WHEREAS, the appropriation of funds from the General Fund will require a modification of the Operating Budget for Fiscal Year 2001, which was approved on December 20, 2000.
- NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for Fiscal Year 2001 to include an appropriation of \$14,705 from the General Fund and allocated to the Cultural Preservation Program for expenses associated with the installation of a Water Well and Irrigation System on the Pow Wow Grounds.
