## APPROVING MODIFICATION OF THE FISCAL YEAR 2001 OPERATING BUDGET TO INCLUDE A SUPPLEMENTAL APPROPRIATION OF \$140,000 FROM THE INDIAN HEALTH SERVICE FOR THE CONSTRUCTION OF SANITATION FACILITIES TO SERVE AKI MAADIZIWIN DEVELOPMENT

WHEREAS, the Tribe's status as a federally-recognized Indian Tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. '1300k <u>et seq</u>.); and

WHEREAS, the Tribe adopted a Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power the provide for the general welfare of the Tribe and its members; and
- WHEREAS, the Tribal Council, pursuant to Article IV, (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, Tribal Council desires to enter into a Memorandum of Agreement with the Indian Health Service in order to receive services and funds to assist with the development of the Aki maadiziwin development. The funds received pursuant to Project BE-01-D22 are \$140,000.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification of to the Operating Budgets for the Tribal Government for Fiscal Year 2001 to include a supplemental addition in the amount of \$140,000.00 from the Indian Health Service to assist non-NAHASDA homes with the well and septic services; Resolution No. #01-1114-08 Page two
