Resetting and Staggering Terms of Office of Members of Commissions in Accordance with the <u>Commissions Ordinance</u>

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(f) of the Constitution to, "create by ordinance regulatory commissions or subordinate organizations and to delegate to such organizations..." such legislative powers as may be necessary to regulate in that area: and
- WHEREAS, the Tribal Council has adopted a <u>Commissions Ordinance</u> which sets forth requirements and directions regard the activities of regulatory commissions; and
- WHEREAS, the Tribal Council recognizes that this ordinance will result in amendments to the membership terms, as well as by-laws, of commissions that will require time to allow this Ordinance to be amended; and
- WHEREAS, the Tribal Council adopted a formula that called for the terms of office of commissioners to be reset so that the terms were both staggered and began on the correct date that conformed in the closest manner to the longest and shortest terms of office of the commission member on each commission; and
- WHEREAS, the Tribal Council met in Work Session on December 20th and determined that the application of the formula to reset the terms of office;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby resets the terms of office of commissioners as required in section 8.01 of the Commissions Ordinance as follows:
