**Approving Supplemental Appropriation for Language/Cultural Camp
Program for FY2002 in the amount of \$19,500 from General Fund**

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the Language/Cultural Camp Program requires a supplemental appropriation in the amount of \$19,500 for costs associated with the 2002 Anishinaabe Language/Cultural Camp dedicated to the memory of Jonny Sam & Doris Wabisis; and


WHEREAS, the appropriation of funds from the General Fund will require a modification of the Operating Budget for Fiscal Year 2002, which was approved on December 19, 2001.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for Fiscal Year 2002 to include an appropriation of \$19,500 from the General Fund and allocated to the Language/Cultural Camp Program for expenses associated with the 2002 Anishinaabe Language/Cultural Camp.

CERTIFICATION OF ADOPTION


