RESOLUTION # 02-0313-01

Adoption of <u>Indian Preference in Employment Ordinance</u>, # 02-600-02, and Repeal of Existing Indian Preference Policies in the Tribe's Personnel Manual

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. s. 1300k et seq.); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, setting Indian preference requirements and procedures promotes the hiring of members and improves their employment opportunities; and
- WHEREAS, the Tribal Council has presented the <u>Indian Preference in Employment Ordinance</u>, at work sessions, to the Executive Director of Operations and the Human Resource Director for comment and discussion; and
- WHEREAS, the Tribal Council finds that adoption of the ordinance is in the best interests of the Tribe and its membership to clearly define how Indian preference will be implemented,

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby adopts the <u>Indian Preference in Employment Ordinance</u>, # 02-600-02, for implementation 90 days after adoption; and

IT IS FURTHER RESOLVED THAT the Tribal Council hereby directs the Human Resource Director to develop the appropriate implementation and/or training plans for complete implementation of the <u>Indian Preference in Employment Ordinance</u> within the 90 day implementation period; and

IT IS FURTHER RESOLVED THAT the Tribal Council hereby repeals section 2.3 of the Personnel Manual and supersedes all other sections which conflict with the <u>Indian Preference in Employment Ordinance</u>.
