MODIFICATION TO ADD THE CIRCLE OF FLIGHT BIA 638 CONTRACT AND APPROVING A MODIFICATION TO THE OPERATING BUDGET FOR FY 2002 IN THE AMOUNT OF \$15,000

- WHEREAS, The Little River Band of Ottawa Indians has a long and proud history as a Nation which pre-dates the establishment of the government of the United States of America, and
- WHEREAS, The Little River Band of Ottawa Indians was a signatory of the Treaty of Washington of March 28, 1836 and the Treaty of Detroit of July 31, 1855 with the United States of America, and
- WHEREAS, The Little River Band of Ottawa Indians status as a federally-recognized Tribe was reaffirmed and restored by the United States Congress in Public Law 103-324, and
- WHEREAS, The Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds for the benefit of the Tribe and its members, and
- WHEREAS, The modification of the BIA 638 Contract and the acceptance of funds from the BIA for the operation of our circle of Flight Program will require a modification of the Operating Budget for FY 2002

NOW THEREFORE BE IT RESOLVED that the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to add BIA Funding for the Circle of Flight Program in the amount of \$15,000 to the 638 BIA Contract for FY 2002.

BE IT FURTHER RESOLVED that the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for Fiscal Year 2002 to include BIA Funding for Circle of Flight in the amount of \$15,000
