**MODIFICATION TO ADD THE CIRCLE OF FLIGHT BIA 638 CONTRACT
AND APPROVING A MODIFICATION TO THE OPERATING BUDGET FOR
FY 2002 IN THE AMOUNT OF \$15,000**

WHEREAS, The Little River Band of Ottawa Indians has a long and proud history as a Nation which pre-dates the establishment of the government of the United States of America, and

WHEREAS, The Little River Band of Ottawa Indians was a signatory of the Treaty of Washington of March 28, 1836 and the Treaty of Detroit of July 31, 1855 with the United States of America, and

WHEREAS, The Little River Band of Ottawa Indians status as a federally-recognized Tribe was reaffirmed and restored by the United States Congress in Public Law 103-324, and

WHEREAS, The Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds for the benefit of the Tribe and its members, and

WHEREAS, The modification of the BIA 638 Contract and the acceptance of funds from the BIA for the operation of our circle of Flight Program will require a modification of the Operating Budget for FY 2002


NOW THEREFORE BE IT RESOLVED that the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to add BIA Funding for the Circle of Flight Program in the amount of \$15,000 to the 638 BIA Contract for FY 2002.

BE IT FURTHER RESOLVED that the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for Fiscal Year 2002 to include BIA Funding for Circle of Flight in the amount of \$15,000

IT IS FINALLY RESOLVED that the Tribal Council authorizes the Tribal Ogema, or in his absence, the Tribal Council Speaker to execute any documents necessary to officially accept funding from the BIA for the Little River Band of Ottawa Indians Circle of Flight Program.

CERTIFICATION OF ADOPTION
