Approving Budget Modification to the Commercial Fishing Education, Training and Development Program Budget in the Natural Resource Conservation Department to Authorize Expenses Associated with Leasing the Trap Net Vessel for Use by Tribally-licensed Fishers

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k <u>et seq</u>.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council, pursuant to Article IV, 7(i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and
- WHEREAS, the Tribal Council did, pursuant to Resolution No. #02-0306-06, authorize an appropriation of \$249,920.00 to be included in the Natural Resource Conservation Department's Fiscal Year 2002 Program budget to establish a Commercial Fishing Education, Training and Development Program to facilitate implementation of commercial fishing operations by members of the Tribe; and
- WHEREAS, the Commercial Fishing Education, Training and Development Program budget included expenses associated with retention of an experienced commercial fisher to provide the necessary training to Tribal members; and
- WHEREAS, the Tribal Council did, pursuant to Resolutions No. #02-0417-08 and #02-0417-09, authorize execution of a Consulting Agreement and Trap Net Vessel Equipment Lease/Option to Purchase Agreement with Charles Matson; and
- WHEREAS, the approved Program Budget did not specifically include expenses associated with leasing the trap net vessel and equipment from Mr. Matson; and

- WHEREAS, the expenses associated with making the lease payments and securing appropriate insurance on the leased vessel can be covered within approved program budget; and
- WHEREAS, Section 4.10(d)(3) of the Budget and Appropriations Ordinance, Ordinance #01-100-04, requires any change in the scope of a program budget to be approved by both the Tribal Ogema and Tribal Council.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification of to the Commercial Fishing Education, Training and Development Program Budget for the Natural Resources Conservation Department's Fiscal Year 2002 Program Budget to allocate \$17,500.00 for lease payments associated with the Trap Net Vessel Equipment Lease/Option to Purchase, including expenses associated with maintenance of that vessel and procuring required insurance on the leased equipment as provided in the Lease/Option to Purchase Agreement.
