Authorizing the Tribal Ogema, or in the absence of, the Tribal Council Speaker to Execute of a Lease Agreement with Hidden Harbor Marina for Dock Space for the Trap Net Vessel

- WHEREAS, the Band's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Band adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, pursuant to Article IV, Section 5 (a)(4) and Article V, Section 5(a)(3) and (8) of the Band's Constitution, the Tribal Ogema, or in the absence of, the Tribal Council Speaker, is authorized to represent the Band and manage the economic affairs/enterprises of the Band, in a manner consistent with the Band's Constitution and resolutions of the Tribal Council; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (b) of the Constitution, has the power to authorize and ratify agreements and contracts negotiated by the Tribal Ogema; and
- WHEREAS, the terms of the Consent Decree entered in <u>United States</u> v <u>Michigan</u> are intended to facilitate the Band's to use settlement funds to assist Band members enter the commercial fishery in waters near the Band's Reservation; and
- WHEREAS, the Tribal Council did approve a Budget Modification to authorize use of funds in the Trap Net 2002 Program Budget for fees associated with leasing dock space for Band members participating in the Commercial Fishing Education, Training and Development Program; and
- WHEREAS, the Natural Resource Commission is recommending approval of the Lease Agreement with Hidden Harbor Marina to lease dock space for the trap net vessel, Cierra, and the Tribal Council desires to authorize execution of that agreement.
