Resolution No. #02-0724-01

Approving a Supplemental Appropriation in the Amount of \$35,000.00 from the General Fund to be used for Expenses Associated with Completion of an Archaeological Survey on the Pere Marquette Acres (Custer) Property

WHEREAS, the Band's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Band adopted a Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council, pursuant to Article IV, 7(i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the Tribal Ogema has requested a supplemental appropriation of \$35,000.00 from the General Fund to be applied to expenses incurred under a proposed Professional Services Agreement to complete an archaeological survey of the Pere Marquette Acres (Custer) property; and

WHEREAS, the amount requested for the archaeological survey expenses was not included as part of the Fiscal Year 2002 Operating Budget; and


WHEREAS, the supplemental appropriation of \$35,000.00 from the General Fund will require a modification of the Operating Budget for Fiscal Year 2002, which was approved on December 19, 2001.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification of to the Operating Budget for the Tribal Government for Fiscal Year 2002 to include an appropriation of \$35,000.00 from the General Fund to be allocated to the expenses incurred under the Professional Services


Agreement with Andrews Cultural Resources for completion of the archaeological survey of the Pere Marquette Acres (Custer) property.

Presentation of Resolution Approving Budget Modification and Appropriating Tribal Funds to Tribal Ogema:


