Resolution # 02-0724-04

Amending the Deadline for Approval and Implementation of Enrollment Commission Regulations From July 29, 2002 to August 7, 2002

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council adopted resolution # 02-0529-03 which adopted comprehensive amendments to the Enrollment Ordinance, and renumbered that ordinance from 97-200-01 to 02-200-01; and
- WHEREAS, the Enrollment Commission has worked diligently in developing regulations to implement the new ordinance; and
- WHEREAS, the Enrollment Commission has also worked diligently to develop the reports requested in resolution # 02-0509-03; and
- WHEREAS, the Tribal Council has received the proposed regulations, as well as proposed corrective amendments to the <u>Enrollment Ordinance</u> from the Enrollment Commission; and
- WHEREAS, the Tribal Council has determined that sufficient time was unavailable to review the proposed regulations and corrective amendments to the <u>Enrollment Ordinance</u> prior to adoption and finds that it is appropriate to extend this deadline;
- NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby amends the deadline set in resolution # 02-0529-03 to reflect an implementation date of August 7, 2002 by the Enrollment Commission; and

IT IS FURTHER RESOLVED THAT the Tribal Council hereby directs that the proposed regulations and corrective amendments to the <u>Enrollment Ordinance</u> be presented at the July 31, 2002 regular meeting of the Tribal Council.
