Clarifying and Setting Stipend Amounts for Committees of the Tribe

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(f) to create subordinate organizations and to delegate to such organizations the power to manage its affairs; and
- WHEREAS, the Tribal Council has created committees *(subordinate organizations)* from time to time and delegated responsibilities under the *Committee Procedures Policy* adopted on April 13, 1997; and
- WHEREAS, the Tribal Council has determined that the adoption of the <u>Commissions</u> <u>Ordinance</u>, 01-100-06, has resulted in confusion regarding the application of the ordinance, the policy and the appropriate stipends in regards to committees of the Tribe; and
- WHEREAS, Section 6 of the *Committee Procedures Policy* directs that the Tribal Council shall set stipends for attendance by Committee Members at committee meetings by resolution;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby directs that chairpersons of committees of the Tribe shall be forwarded a copy of this resolution as notice of the approved stipend rate and the *Committee Procedures Policy* for information;

IT IS FURTHER RESOLVED THAT the Tribal Council hereby sets the stipend rate for Committee Members attending a committee meeting at \$50.00 per meeting with no more than 2 paid meetings per month;

IT IS FURTHER RESOLVED THAT the Tribal Council hereby directs that the stipend rate for committees set in this resolution is effective on August 7, 2002 and shall not be retro-active; and

IT IS FURTHER RESOLVED THAT the Tribal Council hereby directs that committees requiring meetings in excess of 2 times per month may submit to the Tribal Council a resolution, for adoption by the Tribal Council, which identifies the potential number of meetings in excess of the authorized paid meetings, and the reason such meetings are necessary.
