Approval to Enter Into Contract - Joseph Eve & Company: Forensic Audit

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council has entered into an engagement contract with an audit firm for a policy and performance audit, or Compliance Audit, to review the processes and procedures of the Tribe to determine whether we are operating in an orderly and efficient manner in accordance with generally accepted principles and organizational structure; and
- WHEREAS, the Tribal Council has determined that there are activities which require closer scrutiny in order to determine the exact nature of the transactions, which on their face appear to be questionable transactions; and
- WHEREAS, the Tribal Council has determined that continuing with the same audit firm to complete the a forensic audit would result in a more comprehensive audit being completed with cost savings, as well as the audit firm having the requisite qualifications to conduct such an audit;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the Tribal Council Speaker to enter into the engagement letter with Joseph Eve & Company, LLP for the purposes of conducting a forensic audit for the period of January 2000 to September 2002 on specified account transactions.

IT IS FURTHER RESOLVED THAT the Tribal Council hereby authorizes the payment of the \$10,000 retainer to Joseph Eve & Company and delegates to the Tribal Council Recorder the responsibility to monitor and approve expenses related to this contract.
