Approval to Enter Into Contract - Joseph Eve & Company: Fiscal Year 2000 Audit Review

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.); and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Council has entered into an engagement contract with an audit firm for a policy and performance audit, or Compliance Audit, to review the processes and procedures of the Tribe to determine whether we are operating in an orderly and efficient manner in accordance with generally accepted principles and organizational structure; and

WHEREAS, the Tribal Council has determined that the prior audit reports have sufficient identified errors to require the Tribal Council to contract for a review of those documents so as to determine the validity of the documents and the potential requirement for reporting errors or validity of the document to the appropriate federal agencies for corrective action; and


WHEREAS, the Tribal Council has determined that continuing with the same audit firm to complete the a forensic audit would result in a more comprehensive audit being completed with cost savings, as well as the audit firm having the requisite qualifications to conduct such an audit;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the Tribal Council Speaker to enter into the engagement letter with Joseph Eve & Company, LLP for the purposes of conducting a review of the 2000 Audit issued by Robert Lewis and make recommendation for follow-up in regards to those audits.

IT IS FURTHER RESOLVED THAT the Tribal Council hereby authorizes the payment of the \$2,500 retainer to Joseph Eve & Company and delegates to the Tribal Council Recorder the responsibility to monitor and approve expenses related to this contract.

CERTIFICATE OF ADOPTION
