Resolution # 02-1120-03

Approving Supplemental Appropriation for USDA Food Distribution Program for FY2002 in the amount of \$46,910 from the General Fund

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k <u>et seq</u>.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and
- WHEREAS, the USDA Food Distribution Program requires a supplemental appropriation in the amount of \$46,910 for costs associated with the administration of the FY2003 Food Commodities program; and
- WHEREAS, the appropriation of funds from the General Fund will require a modification of the Operating Budget for Fiscal Year 2002, which was approved on December 19, 2001, and committing to a carryover of unexpended funds to FY2003 limited to this specific program.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for Fiscal Year 2002 and authorizing a carryover to the same program for FY2003 of unexpended funds to include an appropriation of \$46,910 from the General Fund – Gaming Proceeds Account. Funds shall be allocated as follows:
