THE MEETING WAS BROUGHT TO ORDER BY CHAIRMAN, DANIEL BAILEY AT 6:30 PM.

MOVED BY MARCELLA LUESBY TO ADOPT THE AGENDA AS SUBMITTED, SECONDED BY JERRY GUENTHARDI. MOTION CARRIED.

MOVED BY JERRY GUENTHARDT, SECONDED BY BONNIE KENNY TO DISPENSE THE READING OF THE JANUARY BOARD MINUTES DUE TO MINUTES NOT BEING READY FOR SUBMISSION. MOTION CARRIED

MOVED BY BONNIE KENNY SECONDED BY MARGARET CHANDLER TO DISPENSE WITH THE JANUARY FINANCIAL REPORT DUE TO A FAMILY EMERGENCY AND REPORT WAS NOT READY. MOTION CARRIED.

DIANE LONN, ENROLLMENT OFFICER, WENT TO THE VICTORIAN PORT CITY FESTIVAL MEETING TO REPRESENT THE LITTLE RIVER BAND. IT WAS NOTED THAT WE WILL ASSUME RESPONSIBILITIES TO ARRANGE THE DRUM TEAM AND DANCERS, BUT THE \$'S WOULD NEED TO BE FURNISHED BY THE FESTIVAL COMMITTEE DUE TO THE AMOUNT BEING ASKED FOR IS NOT IN OUR PRICE RANGE. REMINDER THAT BARBARA MADISON WILL BE COMING ON FEBRUARY 22ND TO MEET WITH THE ENROLLMENT COMMITTEE AND BOARD MEMBERS.

MARK DOUGHER, EXECUTIVE DIRECTOR, REMINDED EVERYONE OF THE CONFERENCE MEETING WITH FRAN AYER AND PATTI MARKS ON SAT. FEBRUARY 19TH AND SUNDAY FEBRUARY 20TH AT THE MANISTEE TOWNSHIP HALL AT 9:00 AM. LEGISLATION IS MOVING FAST WITH UPCOMING SENATE HEARING IN WDC. MORE DETAILS TO FOLLOW.

NEW BUDGET JUSTIFICATIONS FOR THE CHD GRANT WERE SUBMITTED AND REVIEWED BY THE BOARD. MOVED BY BONNIE KENNY, SECONDED BY MARCELLA LUESBY TO ACCEPT THE BUDGET JUSTIFICATIONS AS SUBMITTED AND SEND THEM INTO CHD IN ORDER TO GET OUR FIRST DRAW DOWN. MOTION CARRIED.

IT WAS NOTED WHAT EVERYONE WOULD BRING TO THE CONFERENCE MEETING ON THE 20TH, AND THAT THE BOARD WOULD BE PROVIDING THE DONUTS, REFRESHMENTS, AND PAPER SUPPLIES FOR THE REST OF THE MEAL.
