## **Resolution # 03-0118-8**

Authorizing the Construction Management Team to Execute Change Order #2 with Corvette Construction that increases the contract amount by \$8,014.90 to cover the costs associated with a variety of project elements associated with the finalization of the water system as per the recommendations of Jon Anderson, Indian Health Services. This Change Order involves the tax-exempt side of the overall project and payment for this work should be made through the tax-exempt loan's contingency line.

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. '1300k et seq.); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under article IV, Section 7 to "exercise the inherent powers of the Little River Band by establishing laws and through the enactment of ordinances and adoptions of resolutions not inconsistent with this Constitution...to promote, protect and provide for public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the tribe has determined that the development of the permanent casino/resort facilities is in the best, long-term interests of the Tribe and its members; and
- WHEREAS, the Tribe has, pursuant to Resolution No. #01-0110-03, created a Construction Management Team to manage the construction of the Permanent Casino-Resort project (including those portions of the project falling under the tax-exempt agreement, i.e., the community water and wastewater treatment systems); and
- WHEREAS, the Tribe had previously entered into an agreement with Corvette Construction for the provision and installation of water and sewer mains related to the overall Community Water and Wastewater Systems; and
- WHEREAS, a number of adjustments to the original plans for the water system were necessary to accommodate the actual final needs of the project, all of which were reviewed, recommended and coordinated by Jon Anderson, Indian Health Services; and
