Resolution #03-0122-12

*Acceptance of Contract Funds from Department of Health and Human Services (HHS)
and Approving a modification to the "Continuing Budget for Fiscal Year 2003" in the
amount of \$14,295*

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the acceptance of contract funds from the Department of Health and Human Services (HHS) will require a modification of the "Continuing Budget for Fiscal Year 2003" as set forth in Resolution #02-1221-01.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the "Continuing Budget for Fiscal Year 2003" for the Tribal Government to include contract funds in the amount of \$14,295 from Department of Health and Human Services (HHS) for activities associated with the Low Income Home Energy Assistance Program (LIHEAP).

Funds shall be allocated as follows:

Program # 4315-000 LIHEAP 2003

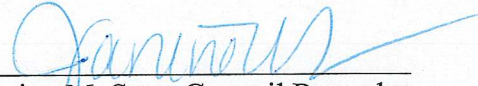

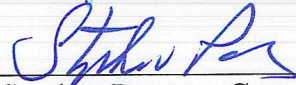

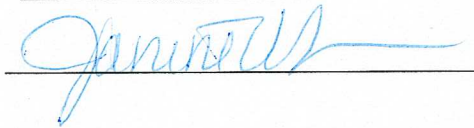
