Resolution # 03-0129-22

- Authorizing the Ogema to Enter Into a Three Year Professional Services Agreement With The Rehman Group on Behalf of the Little River Band of Ottawa Health Center
- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156, 25 U.S.C. s. 1300k, et seq.; and
- WHEREAS, the Tribe adopted a new Constitution pursuant to a vote of the membership on May 27, 1998, which became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is delegated under Article IV, Section 7(a)(1) and (e) to promote, protect and provide for public health, peace, morals, education and general welfare of the Tribe and its members, and to engage legal counsel; and
- WHEREAS, the Tribal Council, under Article IV, Section 7(b), to ratify agreements negotiated by the Ogema on behalf of the Tribe; and
- WHEREAS, the Health Director, as the Ogema's representative from the Little River Band of Ottawa Health Center, negotiated a contract with The Rehman Group regarding billing and collection services for a three year period; and
- WHEREAS, the Ogema has reviewed and approved the contract negotiated and submitted the contract to the Tribal Council; and
- WHEREAS, the contract does not contain a waiver of sovereign immunity and does not contain arbitration or other similar clauses; and
- WHEREAS, the Tribal Council has determined that entering into the contract is in the best interests of the Tribe;

NOW THEREFORE BE IT RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the Ogema to enter into the professional services contract with The Rehman Group for a three-year engagement beginning on the date of signature by the Ogema on the professional services agreement.
