Establishing Accounts Authorized at National City Bank and Designating Signers for Such Accounts

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribe has established a number of accounts at National City Bank of MI/IL; and
- WHEREAS, the Tribal Council has from time to time, by resolution, designated the persons authorized to sign checks drawn from those accounts; and
- WHEREAS, the Tribal Council desires to amend and re-designate the persons authorized to sign checks from certain accounts to only include the names of Tribal government officials holding an office that is subject to election to public office; and
