## Resolution # 03-0205-32

Adoption of Continuing Resolution Regarding Tribal Operations Budget for Fiscal Year 2003

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Ogema is delegated the responsibility, under Article V, Section 5(a)(5), to forward to the Tribal Council a budget for the next fiscal year; and
- WHEREAS, the Tribal Council is delegated the responsibility, under Article IV, Section 7(i)(1), to approve the budget, subject to the subsequent approval of the Ogema; and
- WHEREAS, the Tribal Council adopted the <u>Revenue Allocation Ordinance</u> and <u>Budget</u> and <u>Appropriations Ordinance</u> to identify the processes by which the budget is developed and presented; and
- WHEREAS, the budget presented to the Tribal Council contains two sections financial allocations and narratives; and
- WHEREAS, the Ogema presented the proposed final draft of the budget for Fiscal Year 2003 on December 16, 2002 and a subsequent revised budget on February 5, 2003; and
- WHEREAS, the Tribal Council has not had sufficient time in which to review the revised budget and finds that adoption of the Fiscal Year 2003 budget is not possible on February 5, 2003 which is the deadline set by Continuing Budget Resolution # 03-0108-1; and
- WHEREAS, the Tribal Council desires to allow for sufficient time to review the revised budget submitted by the Ogema;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby extends the deadlines in Resolution 03-0108-1 for action by the Tribal Council on the Fiscal Year 2003 budget from February 5<sup>th</sup> to the Tribal Council meeting of February 12<sup>th</sup> with ratification or veto action required by the Ogema no later February 19<sup>th</sup> in accordance with Article V, Section 5(b).
