Resolution # 03-0402-93

Authorization of Magee Insurance Group as Agent of Record and Approval of On-Line Access to Blue Cross Blue Shield

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Human Resource Department has conducted a review of the Tribe's employment benefit package regarding health and related insurances; and
- WHEREAS, the Tribal Council and Ogema have reviewed the submissions in a Work Session on March 3, 2003; and
- WHEREAS, the Tribal Council has selected the insurance benefit package and the agent of record at the April 2, 2003 Tribal Council meeting; and
- WHEREAS, Blue Cross and Blue Shield offers on-line access to insurance information to allow the Human Resource Department to provide more specific information to employees with questions; and
- WHEREAS, the Tribal Council desires to memorialize the selection of the agent of record and authorization of on-line access;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves Magee Insurance Group as the agent of record regarding the Tribe's employment benefit package from Blue Cross Blue Shield and other related insurances and authorizes the Human Resource Department to obtain onResolution # 03-0402-93 Page 2 of 2

line access, on a stand-alone machine or via the Tribe's network, to Blue Cross Blue Shield information with the approval of the Information Services Director.
