Resolution # 03-0528-141

Approval of Expenditure for Purchase of Tape Back-up System for Management Information Systems (MIS) Department

- WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council is authorized, subject to the veto of the Tribal Ogema, under Article IV, Section 7(i)(1) of the Constitution to approve expenditures of Tribal funds, and
- WHEREAS, the Tribal Council adopted the <u>Budget and Appropriations Ordinance</u>, #01-100-04, which identifies and authorizes expenditure of funds within an approved budget through regulations created by the Tribal Ogema and adopted by the Tribal Council; and
- WHEREAS, the *Purchasing and Procurement Regulations*, #R100-01:AC-01, have been approved by the Tribal Ogema and Tribal Council which directs that authorization of expenditures in excess of \$10,000 must be made by the Tribal Council; and
- WHEREAS, the MIS Department has received bids for the purchase of equipment to provide the Tribal Government's computer system with a tape back-up system

WHEREAS, the MIS Manager is recommending that acceptance of a proposal submitted by CDW Computer Centers, Inc., to provide the necessary equipment at a cost of \$12,088.93; and

WHEREAS, Tribal Council has received a request for approval of the above Expenditure.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River and of Ottawa Indians hereby approves the expenditure of budgeted funds in the amount of 12,088.93 for the purchase of equipment for a tape back-up system for the MIS Department from Program #2000-403, Account # 6200.
