Adoption of Limited Liability Company Ordinance, Ordinance # 03-800-02

- WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council has determined that it is necessary to draft and implement an ordinance which allows for the creation of business structures known as Limited Liability Companies; and
- WHEREAS, the formation of these types of companies will allow the Tribe and its members to create business structures so as to promote economic development, job creation, growth and a strong tribal economy and further the exercise of sovereignty over the lands within the jurisdiction of the Little River Band of Ottawa Indians; and
- WHEREAS, the Tribal Council has reviewed the ordinances in work sessions with individual Councilors, Economic Development and the Tribe's Enterprise Attorney; and
- WHEREAS, the final draft of the Limited Liability Company Ordinance meets the needs identified above and the Tribal Council has determined that it is in an appropriate form to adopt;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby adopts the <u>Limited Liability Company Ordinance</u>, Ordinance # 03-800-02, with an implementation date set at June 1, 2003.
