Resolution # 03-0604-159

Approving Lease of Gill Nets and Net Boxes to Thomas Battice

- **Reaffirming that** the status of the Gaá Čhíng Ziíbi Daáwaa Aníšhinaábek (Little River Band of Ottawa Indians) ("Tribe") as an self-governing People and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- Acknowledging that we are descendants of Grand River Ottawa Bands, signatories of the 1795 Treaty of Greenville (7 Stat. 49), the 1821 Treaty of Chicago (7 Stat. 218), 1836 Treaty of Washington (7 Stat. 491), and the 1855 Treaty of Detroit (11 Stat. 621) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- Considering that, the Tribal Council, pursuant to the Tribal Constitution, Art. IV, sec. 7(b), is invested with the inherent power to authorize and ratify contracts on behalf of the Tribe; and
- Confirming that the Tribe seeks to promote the development of the Tribe's commercial fisheries; and
- **Recognizing that** promotion of the Tribe's commercial fisheries can be advanced by leasing of Tribally-owned fishing equipment to a Tribally-licensed commercial fisher; and
- Noting with approval that the Natural Resources Commission, on April 16, 2003, approved a Lease/Agreement between the Tribe and Thomas Battice, an enrolled Tribal member, for the use of Tribally-owned small mesh gill nets and net boxes; now
- The Tribal Council approves the Lease/Agreement between the Triba and Thomas Battice for Tribally-owned small mesh gill nets and net boxes, and authorizes the Tribal Ogéma to execute the Lease/Agreement on behalf of the Tribe.
