Amending Designated Signers for Accounts at Huntington Bank – Adding Lee A. Sprague, Ogema and Removing Jonnie J. Sam, II and Janine M. Sam, Councilor

- WHEREAS, the status of the *Gaá Čhing Ziibi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribe has established a number of accounts at Huntington Bank; and
- WHEREAS, the Tribal Council has from time to time, by resolution, designated the persons authorized to sign checks drawn from those accounts; and
- WHEREAS, the Tribal Council desires to amend and re-designate the persons authorized to sign checks from certain accounts to only include the names of Tribal government officials holding an office that is subject to election to public office; and

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby adds the following person listed below as authorized check signers on the following checking accounts maintained by the Tribe at Huntington Bank - Account # 1182016445 - Judgement Checking; Account # 3535065219 - Reservation Restoration Trust:
